### **Treasurer's Report:**

Dean Stressed he cannot do the role of Treasurer this year, so we really need someone to take on the role.

Finances are back from the accountant.

\$15,000 loss for 2019. We had 3 sponsors do not pay their sponsorship from 2019. Some of this money has been recovered.

We currently have \$69,514 in the Clubs Investment Account. There is no Outstanding Cheques.

Clubs Accounting System is being updated.

It cost \$394,000 to run this Club. We have a major concern with lack of Sponsorship. It's not overpriced, and all the money goes back to the kids. We don't have the financial backing like St. Mary's and Windsor. St Mary's gets 2.7% of the Leagues Clubs profit. At the end of the day we need more sponsors.

**Under 6 Co-Ordinator:** Under 6 are fine, bit quiet.

**Secretary's Report:** Team nominations are due Friday. Will submit same as last year and add or delete teams as needed. Check FB for upcoming Coaches/Trainers Courses.

Clubs Response: Jim didn't want Lachie Attwood as the Coach. Jim wanted Ronnie. Ronnie was always a package deal with Brian Weightman. Club back's their Coaches. Ronnie did not tell Jim the truth.

Shane Cini asked why the Club let Brian back. Response: Lachie resigned

Craig Campbell – I was away when this all started but I think a decision for a Coach not to let a player trial is wrong. I was in the same position 10 years ago.

Jackie Baragry: Years ago, we had a grading Committee/Selection Panel that went around and watched the kids, maybe Club should look at getting this back.

Meeting went back and forth for a while – Finally Question Was asked to Jim – What is the outcome your after – Jim's reply was for this to not happen to any other kids and it was noted the situation could have been handled better.
